TREATY OF PEACE AND RECOGNITION BETWEEN THE KINGDOM OF BARÛLE AND THE **DOMINION OF BRITISH WEST FLORIDA**

The High Contracting Parties:

KINGDOM OF BARÛLE

DOMINION OF BRITISH WEST FLORIDA

The sovereign nations signing this treaty, thru their respective mediators and to prove mutual good faith, officially concur to announce:

Article 1

By this Treaty, the High Contracting Parties establish among themselves diplomatic relations.

Article 2

The High Contracting Parties shall secure and guarantee to everyone within their jurisdiction the rights and freedoms defined in their respective Constitutions and Laws, as well as respecting the Human Rights.

Article 3

The High Contracting Parties hereby recognize each other as sovereign and independent states under International Law for all intents and purposes.

Article 4

The High Contracting Parties within the international protocol respect and recognize the territorial integrity and Sovereignty of each other. Neither of the High Contracting Parties shall not intervene in the internal affairs of the other, nor will spy or engaged in hostile acts against the other or any other nation.

Article 5

The High Contracting Parties hereby agree to post an electronic link within their internet website to each other, thus symbolizing mutual friendship and strengthening reciprocal recognition.

Article 6

The High Contracting Parties hereby declare their assent to the Vienna Convention on Diplomatic Relations 1961, and their affirmation to abide by all and sundry the provisions of the same.

Article 7

1. Upon the signing of this Treaty, the High Contracting hereby agree to notify each other within 10 business days

by means of a simple electronic mail (e-mail) message, in such case either one decides to renounce to the arrangements mutually made in this Document.

2. In the case that either of the High Contracting Parties would not comply with the articles of this contract, the other would be entitled to suspend the treaty immediately by simply sending an e-mail to the liable High Contracting Party.

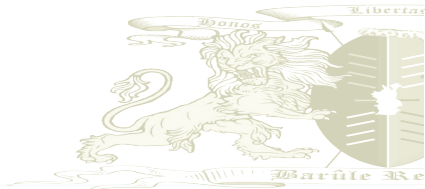
